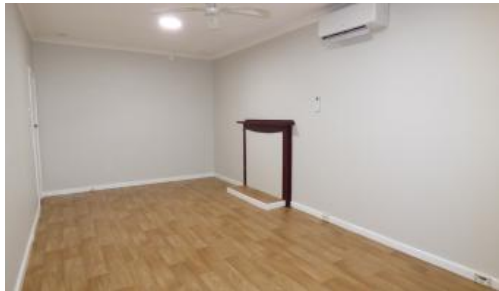

Renovated 3 Bedroom Home

This 3 bedroom, 1 bathroom home is available from 23rd July!

The house has been updated in the last few years including new paint, flooring & kitchen.

All three bedrooms are of good size and all have built-in robes. The main bedroom (larger of the three) has a split system air-con.
